- To ensure compliance with applicable laws, including confirming whether you are 16 years of age or older.
- To improve the content and functionality of our Site.

## 3. Sharing Your Information

We do not sell, rent, or share your personal information with third parties for marketing purposes. However, we may share your information in the following circumstances:

- **With service providers**: We may share your information with trusted third-party service providers who help us operate our business (e.g., website hosting, email delivery).
- **As required by law**: We may disclose your information if required by law or in response to legal requests, such as a subpoena or court order.

#### 4. Data Retention

We will retain your personal information for as long as necessary to fulfill the purposes outlined in this Privacy Policy unless a longer retention period is required or permitted by law.

#### 5. Security

We take reasonable steps to protect the personal information you provide through our Site. However, no method of transmission over the Internet or electronic storage is 100% secure.
